

Terms and Conditions

1. Conditions

Access to and browse the website www.inter.it (hereinafter the **Site**), managed by F.C. Internazionale Milano S.p.A. (hereinafter **Inter**), are governed by these Terms and Condition and imply the acceptance thereof.

2. Intellectual Property Rights
